

7.1 Annual Vestry Meeting Minutes February 18, 2018

- Welcome and Call to Order: The meeting was called or order at 12:00pm by Rev'd Clarence Li, Chair 40 members were registered to vote resulting in a quorum.
- 2.0 Gathering Prayer led by Rev'd Clarence Li.
- 3.0 Remembering the Faithful Departed of 2017 Kathleen Archibald, Marguerite Bandick, Christine Cooksley, John Farrer, Edna Fegan, Ingrid Fletcher, Minnetta Friberg, Wendy Steele, Janet Sutton, Mitchell Williams-Rice. On behalf of the ACW, Julie Stevens gave a dedication to Laurelle Findler, who passed away on January 28, 2018.
- 4.0 Rector's Charge Rev'd Clarence Li reflected on Open Doors, Open Hearts, Open Minds. He wonders what is the future? There are visible signs of Hope & Healing and that St. Hilda's is a place for transformation. Our essentials are Focus, Leadership & Courage. A "Chain of Command" was presented for the Restoration Decision Tree as noted on page 33 of the 2018 Vestry Report. There will be more reciprocal reporting between teams. How do we practice our Mission Principles of Worship (it should be simple and intentional), Hospitality (done with care), & Justice (we discover, share and invite). In conclusion, we are a people on a pilgrimage.
- 5.0 Appointment of Secretary Meg Stevens, Associate Warden, appointed Janet McIntosh as Secretary for the meeting.

- 8.0 Business Arising from the Minutes none
- 9.0 Reception of Reports Clarence Li thanked those who prepared the Reports and to those who serve in our many ministries. Any minor corrections to the Reports shall be referred to the Secretary, Janet McIntosh.

M/S/C: To receive all reports from 9.1 through 9.31 – Mike Starr/Corrinne Newman

Report 9.32 Financial Reports from the Treasurer for 2017 – Bob Maxfield pointed out that 2017 ended in a positive cash flow without needing funds from the CTF (Consolidated Trust Fund). Total revenues were \$242,205 and total expenses were \$226,660. He reviewed the balance sheet as well as income & expenses. Clarence Li directed attention to the "Notes to the Financial Statements (Unaudited) for the year ending December 31, 2017" on p.31 of the 2018 Vestry Report.

M/S/C to receive the Financial Statements for 2017 – Maggie Edwards/Win Wright. Bob Maxfield recommends a Review Engagement be done in 2018 at an estimated cost of \$3000 - \$5000.

10.0 NEW BUSINESS

None

10.1 Budget 2018 – Presented by Treasurer Bob Maxfield who advised the budget was very similar to 2017. There is an account receivable for \$12,000 from RainCity for the Shelter operations. Questions arising:

Why is the Sunday School budget \$600 when expenses were \$78?

- A: Keeping budget same as 2017
- Where would the cost of the audit/Review Engagement come from?
 - A: Restoration Budget

Why is the loan interest part of operating expenses when no other restoration expense or revenue is? Loan Interest is for 1 year.

A: Included for transparency purposes.

Are the lower hydro bills due to not heating the Sanctuary?

A: Yes.

M/S by Roslyn Mundy/Anne Webb: add a Capital Campaign expense of \$1000 to the budget. Motion rescinded after discussion.

Bruce Morris recommends having a separate column for Restoration revenues/expenses in the budget. The loan interest will be removed from the operating budget and transferred to the Restoration budget. Audit expenses and Capital Campaign expenses will be part of the Restoration budget.

Budget 2018 Adopted: M/S/C – Bob Maxfield/Sher Sacks

- 10.2 Review of St. Hilda's Vision Meg Stevens advised the Redevelopment Study Team will meet March 12, 2018.
- 10.3 Update on Restoration Progress Andrew Morin reported that progress is going well. Crew is digging deeper around the foundation than expected due to clay issues. The Building Committee is looking for more members, not restricted to males.

Q: Are there problems with weight on the floor around the piano? A: No

Q: Can the foundation be altered to be used as storage space? A: No, not possible due to the added expense of bringing any space up to code.

Q: Is there an extension to the Sanctuary? A: Yes, a 21' X 21' addition to the NW corner with a crawlspace. Final plans will be revealed soon.

Q: When can we see conceptual drawings? A: The architect and engineer are producing them.

Q: Where are the altar rails? A: Unknown but they are safely stored.

- Q: Will there be stairs to the courtyard? A: Yes, new stairs will be constructed
- 10.4 Update from the Capital Campaign Team Roslyn Mundy & Janet McIntosh reported that the official launch of the Campaign is March 18, 2018. There will be home visits, letters to other parishes asking for a monthly 2nd collection for us, we have consulted with professional fundraisers, Maggie Edwards has Pledge Forms and will be the keeper of the accounts, grant applications will be made but we are seeking assistance on this, a leaflet for the public is in final stages of production.
- 10.5 Update from the Fundraising Events Team Maggie Scott & Margy Grant reported that a bottle/ can return bin has been set up in the breezeway. Plans are underway for a Guess Who's Coming to Dinner event with guests paying for dinner.

9.1 Report of the Rector

"Do not fear, for I have redeemed you; I have called you by name, you are mine. When you pass through the waters, I will be with you... when you walk through fire you shall not be burned, and the flame shall not consume you." ~ Isaiah 43.1-2 (NRSV)

It has been 3 months since St. Hilda's completed the restoration of the sanctuary and had it rededicated. It helps to have the benefit of this passage of time to reflect on this extraordinary year in the life of our parish and to comprehend more fully what had just happened in our midst over the last 19 months since that fateful discovery of the structural instability in June 2017.

These words of Isaiah were lyrics of a praise song, *Fear Not*, I learned many years ago. It is one of those songs that just sticks in the back of my mind (I'm sure you have one of those too) and continues praying through me despite the passage of time and the changes in my life's situation. Isaiah was proclaiming hope to a people in exile from their homeland. *Finding hope in a hopeless situation* – there is something in which we easily identify with given the challenge we had in the last 19 months. A million-dollar restoration for an aging congregation of just about 100 members. How are we going to find the energy alone, lest the money, to restore our facility so that St. Hilda's may continue to witness the love of God on the Sunshine Coast?

"Do not be afraid...I know you by name, I am One with you. Your trouble is my trouble, your joy is my joy." (paraphrase)

As individuals and as a parish, we experienced what it is like **to be known**: not just being known by a God in private prayer, but by an *incarnate* God who anchors love in every aspect of creation. One epiphany for St. Hilda's was discovering that our parish is known by the community we belong to. The Sunshine Coast community did not just find out our plight. We discovered that our plight *became* theirs and many, far more than we ever imagined, reached out to help us restore our *House of Love*. As a result, we grew in our faith and experience of the incarnate God revealed through Jesus, God-incarnate.

"When you're in over your head, I'll be there with you." (paraphrase, The Message)

We have every reason to feel drowned: from fixing a wall to pretty much rebuilding the whole church, from the accessible sacred space at the centre of the village to an inaccessible construction zone where no one knew from one day to another which door to enter the church, and from a quarter-of-a-million

initial budget to \$1.3 million final cost. At every turn, we found someone throwing us a life-saver to keep us afloat: the offering of church space and people's living room for meetings, short-term and long -term financing with unbelievably favourable terms that make bankers cringe. Each growing need was met by a greater generosity. We were met by God whose essence is love in abundance.

"When you're between a rock and a hard place, it won't be a dead end." (paraphr., *The Message*) The Way of Christ (or the Way of Wisdom if you prefer) has no dead end. Who would have ever thought that St. Hilda's would find the vision and courage to explore redeveloping our property for future mission at a time when we hadn't even figured out how to finance the restoration exactly one year ago at the Special Vestry Meeting? We discovered that the costly project was never meant to be a dead end. One of Amy Grant's songs, *Every Road*, echoes with what we had experienced:

> Every road that's traveled teaches something new... and every road that's narrow pushes us to choose...

We chose Love, and Love finds us and walks alongside with us.

2018 left me with a profound sense of gratitude: grateful for the faithfulness of God-incarnate, grateful for the teamwork of the Body of Christ, grateful for experiencing Oneness in joy and sorrow. I want to thank Archbishop Melissa for her unceasing support and encouragement; our deacon Bruce for his extraordinary servant ministry as Project Manager; my beloved wardens Meg, Carol, Mike, and treasurer Bob for the extra-heavy-lifting and keeping suffering fun; Karen who always rises above every challenge and made everyday parish life orderly and beautiful; the Capital Campaign Team and the Fun-Raising Team who must have inspired Obama to coin the slogan "*WE CAN*"; the new Building Committee which took on an impossible mandate in stride; Altar Guild, Worship Committee, Servers, Readers, Intercessors, and Greeters for keeping us focus on Worship; the Contemplative Ministry which held space for us to centre and pray with clarity; ACW and Justice Umbrella for holding Outreach a non-negotiable priority amidst our busyness and chaos; Coffee Hour hosts and Christmas Dinner team who ensured hospitality was in place; the Redevelopment Study Team which carved out space for all to *dream* a little; and every single one of you who makes up what we have deeply cherished as the Body of Christ.

As I completed my ninth year at St. Hilda's and begin my tenth, I testify that God is AWSOME, and so are you.

9.2 Report of the Wardens

It has been an amazing year!

The parish of St. Hilda faced a huge challenge, but the Rector and Deacon remained positive and optimistic, people pulled together, staff, volunteers, and committees worked really hard, the surrounding community was encouraging, contractors gave above and beyond, and we pulled through.

Parish life did not stop when we had to vacate the sanctuary. We kept calm and carried on with a visioning exercise, an outdoor worship service and picnic, and the Canada Day parade. We joined the Syiyaya Reconciliation Movement, considered sponsoring a refugee, responded to a District of Sechelt request for a right of way, held our first Posada, distributed Christmas hampers, held Sunday worship AND coffee in the hall, not to mention hosting continued use of the hall and annex by outside groups. Speaking of the hall, there were so many people who contributed to make it possible for worship to happen there, for example:

• The Altar Guild and others worked each Saturday to set up and Sunday afternoon to take down the lectern, altar, candles, chairs, sound system, coffee, hymnals...

- Katherine gave up the organ and piano and used a small keyboard, and then later a small piano
- Karen put words, music, and credits for all the hymns into the bulletin.
- We all sat on uncomfortable chairs without complaining.

People in the office, Clarence, Karen, and the volunteers, worked on through noise, vibration, and dust, sometimes having to start work when the contractors finished for the day to be able to hear themselves think. The Building Committee, having accepted their volunteer positions before they knew about the building problems, gamely continued and helped Bruce with project management and tasks both small and large. The Treasurer's workload more than doubled, as many more bills had to be paid, and the Envelope Secretary had to account for many more donations. Your Wardens continued our tasks, performing staff and clergy reviews, overseeing finances and hiring a bookkeeper, and working with Church Committee and all the other committees to ensure the smooth functioning of the parish.

Community support included Living Faith Lutheran Church in Davis Bay offering their space for our meetings, donations and loans from Trail Bay, a grant from Sunshine Coast Credit Union, and the Rotary Club catering the reception for the rededication.

Paying for the necessary work was a daunting thought, especially as the cost kept increasing, but the Capital Campaign and Funraising Committees came up with great ideas, the Anglican Foundation granted \$15,000, and we secured bridge financing for the rest from the community and the Diocese. We are not finished yet, but the remaining amount doesn't seem so daunting. The rededication service and community thank you event felt like a great victory party.

Now what? Do we just sit back and enjoy our comfortable pews? Not likely!

We're plunging in to feasibility studies for youth and family ministries and a redevelopment plan for the property (for which we received a \$20,000 Diocesan Parish Development Grant). We're looking at "inreach" and "outreach" possibilities and opportunities for personal and community growth.

We are thankful to all who have served the parish over the past year, and we were happy to see Corrinne Newman recognized for her years of service by being installed in the Order of the Diocese of New Westminster.

Looking forward to another great year with you at St. Hilda's!

9.3 Deacon's Report

Dear friends,

This has been a very full year for your Deacon, and while I celebrate what we have achieved together, I am also glad that 2019 is looking like it'll be more normal.

Parish Ministry – Almost all my available time for the Parish was taken up with the restoration of our sanctuary. My role as project manager required me to meet regularly with the general contractor and sub-trades, tour the site, answer questions and make decisions on construction details, review and approve invoices for payment and try to keep us on budget. I feel really good about all the work (other than the budget bit) and believe that we collectively have done a wonderful job of restoring our space for the benefit of the wider community, as well as providing those who come to worship with a place of peace, security and hope. I am now enjoying having time again for family and for other pursuits.

I seemed to have slipped back into the role of chaplain at Branch 140 of the Royal Canadian Legion. Speaking at Remembrance Day, where such a broad cross-section of our community gathers, provides a wonderful opportunity to encourage residents of the Sunshine Coast to adopt attitudes of hope, compassion and generosity. I am very grateful to be able to represent St. Hilda's in this role.

Diocesan Ministry – I continue in my role of Archdeacon for Deacons. The role involves supporting existing deacons to reach their full potential in their ministries, and to encourage others who are called by God to understand their vocations as ordained ministers in our church. I find the work extremely fulfilling as, for the most part, it uses my gifts of encouragement and communication.

Workplace Ministry – For deacons, exercising our ministry in places outside the parish's usual reach is a central part of our calling. For me, years ago, it was my job at Claytons, and the numbers of staff who asked me for counsel for their lives, that led me to understand that I am a deacon. This past year, it was my involvement with the construction workers that provided opportunities to exercise my workplace ministry and I have tried, where possible, to bring those experiences to the attention of our parish, so that we can all be part of ministering to our community. I also spend time with the staff and clients of the accounting firm where I assist with personal income tax work.

My hope for our parish is that we will recognize and act on raising another deacon. You may be aware that I will turn 65 in a couple of weeks, and am currently in the first of two one-year extensions, before I become "retired clergy." So I invite you to consider whether God is calling someone else to be Deacon at St. Hilda's and be courageous in speaking with them and with our rector. In the meantime, I'll continue to be present in the parish and the community.

9.4 Music Director Report

Greetings and blessings to all of you!

Of course the major highlight of this year was our move back into our newly renovated Sanctuary in November. The choir and I are enjoying our new location in the beautiful West Transept and the inspiring, beautifully enhanced acoustic due to increased reflective surfaces and removal of the textured ceiling.

The choir gave a soulful and moving rendition of Sanctuary of Grace by Joseph M. Martin at the Rededication Service on November 4th in the presence of Archbishop Melissa Skelton.

Our beautiful instruments were carefully preserved during the renovation. Thank you to Jon Eriksson and Karen Weatherington who housed the Yamaha grand piano at their home for 5 months. Marianne Huestis made two trips to St. Hilda's in October and November to put the reed pipes back in our Casavant Pipe Organ as well as tuning and scheduled maintenance.

The music director's office is a newly created space in the organ loft which now contains all the choir music and keyboard music. The lovely skylight and carpet are a great addition. Thank you to Liz Miller who donated a desk.

The choir enjoyed our annual Carol Sing-a-Long in December with guests Caitlin Hicks and Gordon Halloran who performed original stories. The choir has gone through some transition this year as we mourned the loss of long-time member, Hildegard Erber. Donna Walsh-Wheeldon is also missed as she relocated to Vancouver Island in the fall. We would like to invite new members to come and sing with us.

As part of my professional development, I attended the British Columbia Choral Federation's ChorFest in May. Held in Richmond, we enjoyed rehearsing world and gospel music with Vancouver choral conductor, Brian Tate, culminating in a 200-voice concert on Mother's Day (including 20 people from the Sunshine Coast!).

Upcoming events in Spring 2019 include a Gala Concert Fundraiser "An afternoon of chamber music with Katherine & friends" for the building fund to be held on March 10, 2019, 4pm and the relaunch of the *Music Arising!* St. Hilda's Recital Series.

Thank you to local musicians for their support during the year with special fundraising concerts:

9.5 Office Administrator

Working while under construction has certainly been challenging at times. With different contractors in and out doing their thing, there was always something going on around us. There were a few days when we had booming bass notes pulsing through the Sanctuary floor into our offices when the workers put on their music to get them through their work day! A couple of days we had to vacate quickly and come back later so that spray foam insulation could be installed in the basement walls. Then the gearing up for moving back into our Sanctuary.

In the fall, a new-to-us computer was purchased and installed in the Volunteers' Office. It can now access the Xerox machine directly. With all three of the office computers connected to the "Vault" (our server name), it is much easier to share documents and access files.

The church building is still a busy place with our regular user groups (5 AA, 2 Al Anon groups, 1 Overeaters Anon, Parkinson group, 4 Girl Guide groups, Tai Chi, Pilates Class, A Capella Strait). Waldorf Ballet moved into their new facility in the fall and Parkinsons' finished here in December. The AA and AlAnon groups are still using the Annex and prefer the space there. With the Seniors Activity Centre in Sechelt undergoing renovations, we had three groups temporarily relocate here for the duration. Greencourt closed its doors the end of January 2019 so 3 new groups have joined the ranks: Tuesday night AA, Memory Café, and Stroke Recovery Support Group.

My daily work still consists of bulletin preparation, facility use and management of invoices, inquiries and payments, filing, and all the little details pertaining to running an office.

In October, I applied and was hired to be the Office Administrator at St. John's United Church in Davis Bay. With this part-time job and my job at St. Hilda's, I am finding myself having to be more careful in scheduling my time and determining my limits.

Many parishioners and friends of St Hilda's donated socks, scarves and caps for the Mission to Seafarers and hand-knitted caps were sent to the diocese up north. Also, many of our members are involved in the Prayer Shawl Ministry (see separate report).

This past year, we hosted 2 funeral receptions for long serving ACW members Bobbi Kelly and Hildegard Erber. A donation of \$600 was received.

The amount in our distribution funds given for the Church Remediation is an one time amount as these were funds we had invested towards a new church hall.

Funds are distributed locally and abroad.



The Building Committee had been in abeyance pending the remediation of the Sanctuary. The first meeting since the completion of the remediation project was held on January 21, 2019.

The committee met to consider the current List of Building Issues and to address a request from the Church Committee to explore the possibility of converting a portion of the Annex to living space for a caretaker which would include shower and basic kitchen, and a lockable door inside the annex entry. Andrew Morin prepared a sketch of the required space an approached the Sechelt Building Department regarding the Annex conversion. While there will be a discussion between the Building Department and the Planning Department to formulate an opinion, there was little optimism for a positive response as the permit for the current addition was not based on the area being a dwelling and therefore not likely to meet those standards.

The following List of Building Issues was reviewed and will be addressed as time and weather permit.

- 1. Rot in the post(s) supporting the bell tower
- 2. Timer on the bell tower light needs to be located and re-set or replaced by a photocell to operate the light dusk to dawn.
- 3. Some moss and tree debris on the roof of the Church Hall
- 4. The stairwell to the basement of the Church Hall should be cleaned
- 5. The Church Hall basement holds discarded material (old signs etc.) which should be disposed of
- 6. Damaged screen over a hole in the north exterior wall of the Church Hall
- 7. Garbage (old tires etc.) should be removed from around the garbage bin area (done?)
- 8. Walk way railing along the ramp leading out from the kitchen is not secure
- 9. Some question as to whether or not all the exterior lighting is functional
- 10. Looks like the Garden Shed roof was not replaced when the Church Hall roof was redone. Perhaps some consideration should be given to expanding the Garden Shed
- 11. On the south exterior wall of the Church Hall there is a rotting plywood panel which should be replaced
- 12. The small padlocked door on the south wall should be checked periodically to ensure it is secure
- 13. Debris gathers in the roof valleys of the Church Hall which, if left, can potentially wick water under the adjacent roof shingles
- 14. Downspouts which no longer empty into the drain tile (due to blocked drains?) should be extended to direct the rain water further away from the building
- 15. The concrete walkway leading into the Shelter building poses a tripping hazard due to the soil which has worn away at the head of the path
- 16. The exterior light fixture near the main entry to the Annex was not securely installed
- 17. The decking and posts for the Annex emergency exit door requires attention
- 18. Garbage locker door
- 19. Develop estimate for constructing a caretaker suite in the Annex (Andrew to sketch a plan and approach the District of Sechelt regarding permits.)

- 20. Outdoor lighting (security and aesthetics)--timers to be considered
- 21. Door trim and baseboard in the Gathering Room hallway
- 22. Diffuser missing from florescent light in Gathering Room (Bob to source from Eecol Electric)
- 23. Replace missing downspout section near the back door of the Hall.

9.8.1 Building Restoration Project Manager Report

My spiritual director once asked me why I volunteer for roles. Especially for roles that might grow beyond their original scope. I don't have an answer to this question, other than "well, someone has to do it". Taking on the role of Project Manager for the building restoration certainly fell under this category.

The task of re-building our sanctuary started out as a relatively minor job. In late 2017, we knew we had structural issues, brought about by a weak truss design. We expected that the weakness could be corrected by installing cables across the sanctuary, thereby creating the usual triangle shape that gives buildings strength. Cost was estimated at about \$250,000, for which we had the money to pay.

However, as drywall came down to provide access to the trusses, it soon became apparent that the problems were far more severe. The original architectural design, typical of the mid-1980's, did not have any roof overhangs and minimal rain shielding for windows and doors. It worked in dry California, but not in rainy west coast BC. So, like many condominium buildings built at the same time, our building leaked, as gutters overflowed and water ran inside the walls. And as wind drove rain in through seams around windows and doors, we ended up with rotten walls and window frames.

In addition, budget constraints at the time of original construction led to construction shortcuts. There was no plywood on the roof, required to stiffen the trusses and keep the building square. Perimeter walls were built with low grade twisted wood that had been straightened by cutting partway through, resulting in weak walls. The building was not connected to the foundation. The balcony floor, on which the organ rests, was built without joist hangers, and was starting to fall in. All the drainage around the building was plugged as there was no way to clean out the drain runs. And there was more.

So the scope of the work expanded until eventually we had to rebuild the entire main floor of the church. New drainage was installed around the building to carry away roof and ground water. All the walls were stiffened and new windows installed. The roof trusses were braced with gussets and the exposed rods. Plywood was nailed to the trusses and a new roof installed. The seismic strength of the building was increased significantly over what was in place before and the entire building was anchored with the new transept. Rain screen and new siding was installed to provide much better rain protection.

Naturally all the additional work added significantly to the cost of the project. With all billing completed, total cost is approximately \$1.35 million. Had we been a commercial enterprise, it would have been much more, but many contractors, notably Spani Developments, the general contractor, reduced their billing and donated time and materials so that the parish would not be adversely encumbered. Without this generosity, we would not have been able to rebuild St. Hilda's sanctuary.

On November 4, 2018, with Archbishop Melissa leading us, we moved back in into our restored sanctuary. And we have continued to enjoy the enthusiasm of the community over the results of our work.

At a recent Diocesan event, I was showing Sher Sacks' video of the restoration project. Those watching had tears in their eyes. Because while I was narrating, talking about structural issues and costs, up on the screen, the video was showing parish members with big smiles as you carried on the ministries of our parish.

In retrospect, now that the work is complete, taking on the role of project manager has been hugely rewarding. I am astounded at the levels of generosity from parish members, contractors and the Sunshine Coast community. I am inspired by the enthusiasm and positive attitude that permeated the whole process. I believe that the congregation of St. Hilda's continues to exhibit a faithful response to God's call to be a people who take our place in God's mission to this community.

This Committee was formed in January 2018 and has met regularly throughout the year on most Tuesdays and will continue to meet in 2019 until our goal of raising \$1 million is met.


As of December 31, 2018 approximately \$750,000 has been raised with an additional \$177,000 in outstanding pledges to be received. Campaign activities included holding a raffle for donated prizes, creating a pledge campaign, home visits, grant applications, direct appeals to businesses and individuals, presentations to organizations, and an extensive advertising campaign in print and digital media.

Online giving was enabled through St. Hilda's website and CanadaHelps as well as GoFundMe. A donated sign was erected on St. Hilda's property to mark the progress of the Campaign. A Celebration event was held for donors and the public on November 18 to mark the completion of the majority of the work and a return to using the Sanctuary. A special Donors' Book was created and is on display in our Narthex.

🕅 9.10 Cemetery Board

The Cemetery Board met five times in 2018. Here are some highlights of the year:

- Altered Cemetery Bylaws to conform to the new BC Societies Act and to update several articles to conform to our current practice.
- Adopted a new fee schedule, simpler and more comparable to average fees on the Coast.
- Hosted an inspection from a representative of the provincial government agency responsible for cemeteries.
- Decided on a proportion of fees (20%) that will go towards operations (staff time, office overhead), and on a proportion of the fund to transfer on a one-time basis to the 2018 operations budget for past services.
- Hired a worker to periodically clean up the cemetery grounds. Landscaper and parish volunteer Robert Watson cared for the portion of the cemetery near the North entrance gate.
- Decided to proceed with planning a new Memorial Garden.

There were seven interments in 2018.

The balance of the cemetery fund at December 31 was \$10,000.

9.13 Contemplative Ministries Report

The Contemplative Ministries continue to attract not only "regular attendees" of St. Hilda's, but also "friends" of St. Hilda's, members of other churches as well as the "unchurched." The three contemplative groups offer different approaches to God, which supplement and enrich Sunday morning services for some; for others they offer alternative approaches. The groups have one common feature —the opportunity to find and experience the Divine by "turning inward" in stillness and silence.

In the Christian tradition, Contemplative Prayer (or contemplation) is considered to be the pure gift of God. It is the opening of mind and heart - our whole being - to God, the Ultimate Mystery, beyond thoughts, words, and emotions. Through grace we open our awareness to God whom we know by faith is within us, closer than breathing, closer than thinking, closer than choosing - closer than conscious-ness itself." Contemplative Ministry at St. Hilda's aims to connect seekers to spiritual practices working toward the aforementioned goals. At the beginning of 2018, our ministry was comprised of the Gospel of Thomas Group, Wednesday Wisdom Circle, monthly Inner Journey (CRMC), and the self-guided Meditation Labyrinth located outside the front entrance of the church. The ministry is led by laypersons with support and encouragement from the Rector.

By the end of 2018, The Gospel of Thomas Group and the Inner Journey (CRMC) gathering were not being held. The Wisdom Circle, which incorporates elements of the Thomas Group (and the earlier Centring Prayer Group), continues to meet on Wednesdays at 8:00 am in the welcoming West Transept of the Sanctuary.

If the Rector receives expressions of interest, more contemplative groups could be established to meet later in the morning, during the afternoon or in the evening. All contemplative groups are open to the wider community.

9.21 Redevelopment Team Report

The Redevelopment Study Team has met since March 2018 to explore the possibility of future church property redevelopment.

The Team under the guidance of Tasha Carrothers of the Diocesan office, held a visioning meeting on March 12, 2018 to seek input from parishioners regarding their thoughts regarding future development. It was clear that there was a strong desire for any redevelopment to include housing with multi-use communal space and a community kitchen and garden. The groups were in agreement that housing be inclusive and affordable as well as "green". It was also important that the redevelopment of the property meet the community's needs.

In considering the wishes of those who provided input, the team took on the task of exploring the experiences of other churches undergoing similar redevelopment. Development partners were also approached to gather exploratory information. Local sources of information were also considered. Guidance was sought from the District of Sechelt regarding zoning restrictions on the church property. The team was given some encouragement that re-zoning may be considered should a redevelopment plan fit the needs of the Official Community Plan in regard to affordable housing.

As we worked toward developing a plan for the future, the Redevelopment Study Team contracted with three local consultants with expertise in housing and development. The three have developed a Feasibility Study Work Plan that will engage various stakeholder groups and explore the viability of various development options. The study is funded through a \$20,000 Diocese grant which was awarded to Saint Hilda's for 2019. The work plan will be presented to the Vestry in February 2019.

The proposed timeline for the Feasibility Study is February 2019 through May 2019. The expected outcome of the study is a report presenting 1 to 3 scenarios as options for redevelopment. It is worth noting that the Redevelopment Study team recognizes that no further action regarding property redevelopment will be taken which would place an additional financial burden on St. Hilda's congregation.

9.24 Social Justice Umbrella Report

In 2017, the Social Justice Umbrella was formed out of the Millennium Development Goal Committee. As we wholeheartedly confirmed our commitment to continue with our valuable partnership forged with the local Rotary in 2009, we felt St. Hilda's needed a broader justice group to include other important justice efforts . New members always welcome.

We continue to be enriched by our partnership with the Rotary to support high school students in Ndandini, Kenya, with scholarships assisting with their school fees. We are blessed to be part of the heart-warming stories of the difference this is making in the lives of the students, their families, and their wider community. Our deep gratitude to Terry and Jan Umbach of the Rotary, who took a tour group of tourists to Ndandini in 2008, and made a life-changing connection with the local community who were suffering from years of severe drought. Their involvement continued to grow in multiple ways from water to education. As they retired this past fall from spearheading the scholarship program, Terry and Jan thanked St. Hilda's and asked us to stay committed to providing scholarship support, which they believe is the most important contribution St. Hilda's can make to Ndandini. We say hello to Tanya Hall who is the new Rotary contact for Ndandini scholarships, and we look forward to working with her.

Our own Donna Walsh Wheeldon and Carol Eades made a trip to Kenya Oct 2018, and made an inspiring presentation to the parish about their trip, keeping our connection with Ndandini very much alive. We were sorry to see Donna leave the Sunshine Coast later in the fall, and thank her for her significant contribution to St. Hilda's and the Ndandini fund-raising efforts over the years. We thank Carol Eades for stepping in and taking on more of a role with our Ndandini/Rotary connection. Immense gratitude to parishioners who contributed over \$3100 towards scholarships in 2018. While somewhat less than previous years, it is remarkable given our serious renovation debt situation. Unfortunately, due to a change in eligibility with the Belleville Rotary, our 2018 Ndandini donations may not be eligible for tax deduction. The Sunshine Coast Rotary is working to rectify this in 2019.

In 2018, Indigenous Justice continued to be the primary focus of Justice Umbrella efforts, with particular regard to providing the parish with Truth and Reconciliation education opportunities. A book series developed by the Mennonite Church has been invaluable. In the spring, our ecumenical study group completed book 1, *Wrongs to Rights: How churches can engage the United Nations Declaration on the Rights of Indigenous Peoples*, and this fall started book 2, *Yours, Mine, Ours: Unravelling the Doctrine of Discovery*. These studies have been very eye-opening for the participants. We highly recommend this opportunity, and new participants are welcome. Parishioners also participated in various Truth and Reconciliation Dialogue Circle and Kairos Blanket Exercise opportunities led by Nancy and John Denham, and participated in some shíshálh Long House events/ceremonies. To further encourage the passage of Bill C-262 proposed legislation, book study members sent messages to various Senate members, where the Bill awaits final approval.

In order to give St. Hilda's a visible presence at various justice related public events, a Justice Umbrella banner was created, and was carried by parishioners at several 2018 events including a rally against Kinder Morgan pipeline, a civil disobedience action in support of First Nations against the Trans Mountain proposed pipeline on Burnaby Mountain, and the Sunshine Coast PRIDE day. The banner was also carried at the Sechelt Canada Day parade in conjunction with the Spirited Drumming Circle, and the local syiyaya Reconciliation Movement. Umbrella members also attended the Valentine's Day memorial rally and walk for Murdered and Missing Indigenous Women.

David and Stephanie continued to represent St. Hilda's in preparing meals for the residents at the Upper Deck Homeless Shelter once a month. (The shelter continues to need meals prepared for weekends.) On the advocacy level, the Rector and Meg Stevens continued to represent St. Hilda's at the regular meetings of the Sunshine Coast Homelessness Advisory Committee (SCHAC). St. Hilda's also partnered with RainCity Housing and Support Society on Sunshine Coast to host the first community Posada during the Christmas season to raise awareness for the plights of migrants and those who are homeless.

Justice Umbrella members also participated in the parish discussion in response to a request to sponsor a refugee. Although that particular situation was resolved elsewhere, the discussion was very beneficial and did plant a seed. We recognize the need to become further acquainted with the processes involved in sponsoring refugees, to better prepare for possible future needs.

In closing, we wish to particularly thank Maggie Scott, who is 'retiring' from the Justice Umbrella. Her contribution over many years has been much appreciated, and we look forward to her continuing efforts with the Ndandini scholarship 'knapsack' fundraising.

Holly donations were very successful. We were able to send school supplies for 24 children (\$72.00) through Plan International for one year, and the rest (\$120.45) was put into the building fund. Thank you, everyone.

The Christmas pageant once again brought to us the true meaning of Christmas. A big thank you to all those who participated. It told the story of the Nativity, along with a story of a modern homeless family. The blending at the end joined us all together. The Nativity is not just something that happened 2000+ years ago, but something that happens all around us.

We have taken the names and addresses of as many families as possible who have come at least once to St Hilda's, and added them to our mail-out list. We mail out lessons, Bibles, seasonal activities and background information on our Anglican Heritage several times a year to keep in touch with those who have brought their children to our church and to help parents teach their children about Jesus and his love, as well as our liturgical traditions. We have 21 families with 35 children on our list this year.

We shall continue with the regular Sunday School format and see what the future holds.

9.27 Worship Committee Report

- 1. The Worship Committee is continuing to work on liturgical prayers and Eucharistic Prayers that reflect the community of St Hilda's and it's themes of justice, worship and hospitality.
- 2. We worked with Clarence for the planning of the various services throughout the Easter Season, Advent and Christmas especially.
- 3. We have been compiling a collection of hymns that not only reflect our themes, but also reflect the theology of who we are that Katherine and the choir can incorporate along side our current hymn books. We are constantly looking for hymns that use ideas and concepts from recent biblical scholarship, science, and current justice concerns.
- 4. The committee has a resource file that Clarence constantly updates with our various submissions.
- 5. Through a variety of resources, we are gathering and composing liturgical prayers that fit who we are as people living on the West Coast where nature, reconciliation and life-giving themes are important. We are currently using a *Eucharistic Prayer from Celtic Influence* which the committee composed and a *Eucharistic Prayer of the West Coast* which we have adapted from the Liturgy of the Islands and Inlets from the Diocese of British Columbia.
- 6. We continue to find resources that will fit with various feast days or celebrations such as the Celtic feasts for St. Patrick and St. Hilda, Indigenous Sunday and Solstice for June and the Season of Creation in the Fall.

8. Considering the future and the next generations that will be part of St Hilda's, we are discussing how we can create parallel alternative kinds of worship that will be appropriate and meaningful.

Notes to the 2018 Financial Statements (UNAUDITED) For the Year Ended December 31, 2018

1. The 2018 Financial Statements are presented following the Guide for Financial Statements for Not-For-Profit Organizations provided by the Canadian Institute of Chartered Accountants (CICA) published in 2013.

Fund Accounting: In 2013, the parish switched to the Funding Accounting method for financial reporting and set up restricted funds to record revenues and expenses designated for specific projects and purposes.

In 2013, the Vestry approved the amalgamation of the former Building Fund, Capital Fund, and New Hall Fund into the Building & Maintenance Fund. In 2014, Church Committee approved a motion to merge the Annex Fund into the Building and Maintenance Fund and have the fund renamed as **Property Fund** to better represent its nature.

The history of these various funds is as follow:

Building Fund: a sinking fund set up for major repairs of the property of the parish

- **Capital Fund:** set up in 2011 to tidy up a myriad of designated donations for small projects of the Parish with the bulk collected when there was a need for a sound system.
- **New Hall Fund:** set up at one point to raise funds to build a new Parish Hall. In 2014, Church Committee approved to use money formerly designed for a New Hall to renovate the parish kitchen. The balance of funds given for the New Hall (\$15,438 as of December 31, 2016) will continue to be tracked as an internally restricted amount within Property Fund until such time when Vestry may decide to use the funds for other purposes in the future. At the Special Vestry Meeting held on October 15, 2017, the Vestry decided to remove the restriction in order to help finance the restoration of the church.
- Annex Fund: formerly the Preschool Building Fund to hold the money received from the Sechelt Preschool Association when it was dissolved. In 2013, new funding was received from various sources, designated for the renovation of the Annex as a multi-purpose space.

In 2018, the church went through a complete restoration which was completed by November 2018. Total capitalized costs were \$1,377,325. Donations received for the property fund in 2018 were \$500,297. In addition, St. Hilda's entered into two (2) loans to fund the restoration – see note 6); and liquidated CTF Investments in the amount of \$180,000 – see note 5). As of December 31, 2018, the Property Fund has a balance of \$639,092.

The **Cemetery Fund** was set up according to the by-laws of St. Hilda's Pioneer Cemetery Board and is part of the requirement of the Consumer Protection BC, the provincial regulator for cemeteries and funeral services. Fees collected for interments and burials are kept in a separate fund for the perpetual care of the grounds. In 2018 a special meeting of the Cemetery Board agreed to move \$5,768 to the Operating Fund to cover administration and operating expenses.

The **Development Fund** was set up at 2013 Vestry as an endowment fund to receive any unrestricted bequests the Parish given from time to time. In 2013, Church Committee passed a policy on unrestricted bequests to enable the Parish to hold funds from such bequests as capital to provide income for ministries. The policy specifies that 50% of any income earned could be used for operations and the other 50% may be deposited into a New Ministry Fund to provide seed money for new ministry in the parish. In 2018, a new bequest of \$10,000 was added to the Fund. The **New Ministry Fund** was set up in 2014 Vestry to provide seed money for new ministries in the parish approved by Church Committee. The Fund receives 50% of the earned income of the Development Fund each year end according to a policy adopted by Church Committee in 2013. Balance as at December 31, 2018 is \$28,370.

The **Organ Fund** was set up in 2011 for the future upkeep of the Casavant Pipe Organ. In 2014, the net book value of the Casavant Organ was transferred from the Operating Fund to the Organ Fund for better presentation purpose. As of December 31, 2018, \$6,544 is available for future organ repairs and improvements.

The **Rector's Discretionary Benevolence Fund** was set up by the Church Committee in 2012 to provide benevolent outreach to those who are in need. The Rector provides the oversight for the disbursements of the funds and reports to the Parish during annual Vestry.

3. Flow through funds are those funds contributed to the congregation for transmission to other charitable organizations. The revenues and expenditures will always be in agreement. The funds are held in trust and may not be utilized for other purposes. Therefore, any unpaid balance is treated as a liability owing on the balance sheet. The amount raised for various charitable purposes in 2018 is as follow:

4. Capital Assets: All tangible assets and improvements having a value of \$5,000 or more are required to be reported at either the original cost, or if that is not available, they may be capitalized at a reasonable appraised value.

The church restoration was complete at the end of November 2018 and the associated project costs, in the amount of \$1,377,325, were capitalized. Amortization will commence in January 2019.

- 5. **Investments:** In 2018, Church Committee agreed to withdraw \$180,000 from the CTF Investment account to help fund the church restoration. The market value of the Investment account at December 31, 2018 is \$59,851
- 6. Loans Payable: a) Trail Bay Development In 2018 a loan agreement was set up with Trail Bay Development to assist with the parish re-build. The loan was in the amount of \$300,000, interest accrues at prime rate and the loan is due after 3 years. Accrued interest for 2018 in the amount of \$6,390 was paid in December 2018, along with a principal payment of \$50,000. Balance owing as at December 31, 2018 is \$250 000. In 2019, all "Property Fund" donations will be assigned to pay off the loan payable. b) Diocese of New Westminster In 2018, the parish was authorized to borrow up to \$500,000 from the Diocese of New Westminster with an initial term of five (5) years at 0% interest, and principal payments of \$1,500 monthly will commence in January 2018. Current amount borrowed and outstanding on the loan at December 31, 2018 is \$465,000.
- 7. **Sabbatical Reserve:** Starting in 2017 and continuing for five (5) years, a yearly reserve of \$3,000 is being provisioned for future extended sabbatical. The balance at December 31, 2018 is \$6,000.
- 8. **Deferred Revenue in New Ministry Fund:** In 2017, the parish was awarded a Parish Development Grant from the Diocese of New Westminster, in the amount of \$15,000, for the development of a youth ministry through the engagement of art and culture. Sum Branding+Design was contracted to research and develop the ministry. This project was temporarily suspended in early 2018 deal to energies redirected to the church restoration and resumed in November 2018.
